Notes to Fincancial Statements

The organization provides charitable aid to the indigenous Quechua tribes of Peru with an emphasis on aiding children. This is accomplished primarily through free dental services as well as direct handouts of blankets, shoes, and other goods.

- A The Organization generates revenue by accepting donations of alpacas and selling the animals at auction.
- To generate additional revenue, the Organization produces an annual calendar and sells advertising space to alpaca breeders. Income and expenses will sometimes occur in contiguous calendar years.
- A local dentist performs services on behalf of the organization year-round. The organization reimburses the dentist for expenses incurred and provides for a monthly salary for the dentist and dental assistant.
- D Travel expenses include the cost of volunteers' airfare from the U.S. to Peru and back, as well as travel and transportation costs within Peru.
- The organization makes periodic donations to Peruvian charities, particulary the Mosqu Runa orphanage which is run by the Catholic church. Donations are sometimes cash, but often are in the form of blankets and shoes given directly to the orphanage children.
