#### Notes to Fincancial Statements

The organization provides charitable aid to the indigenous Quechua tribes of Peru with an emphasis on aiding children. This is accomplished primarily through free dental services as well as direct handouts of blankets, shoes, and other goods.

- Donations are received from the general public as well as from other charitable foundations. Product sales and advertising space in the annual Quechua Benefit calendar are sold to generate supplemental income.
- Hotels and Meals primarily consist of reimbursement of these costs incurred by a local dentist who provides services to the Quechua people on behalf of the organization on a year-round basis.
- A local dentist performs services on behalf of the organization year-round. The organization reimburses the dentist for expenses incurred and provides for a monthly salary for the dentist and dental assistant.
- D Travel expenses include the cost of volunteers' airfare from the U.S. to Peru and back, as well as travel and transportation costs within Peru.
- E The organization makes periodic donations to Peruvian charities, particulary the Mosqu Runa orphanage which is run by the Catholic church. Donations are sometimes cash, but often are in the form of blankets and shoes given directly to the orphanage children.
